#### Basic Laws and Regulations in Bahrain

The Central Bank of Bahrain and Financial Institutions Law 2006 ( ' CBB Law ' ) was promulgated on 6 September 2006 with the issuance of Decree No. (64) of 2006. Decree No. 64 implemented the CBB Law and repealed the BMA Law of 1973 as well as the Insurance Law of 1987.

Article 68 of the Law regulates the work by stating that the employer shall maintain a special file for each employee including in particular, the employee's name, age, residential address, marital status, residential address, nationality, job or occupation and qualification and experiences, date of employment, current wage, and all modifications to this wage, the leaves, the date of termination of service and the reasons thereof. Wages At present, Bahraini nationals who hold high school diplomas are entitled to a minimum wage of BHD 270 monthly. Bahraini nationals who hold diploma degrees are entitled to a minimum wage of BHD 350 monthly, and Bahraini nationals who hold university degrees, are entitled to a minimum wage of BHD 400.
